CHAPTER 1

There are five theory levels of the language, namely; the level sounds in phonetic-phonology field, the level of words and forms in morphology field, the level of sentence in syntax field, the level of meaning in semantics field, and the level of language use in pragmatics field. One of those fields in syntax fields, what most people mean by the word grammar.

Language is system of meaning that is created in oral and written form. It is to say that language as a system of meaning is implicated into two types in social language is created and gives massage to the listener and readers. Meaning form, and experience are the linguistics' material.

Language as a source for making meaning which is situated in a context of situation and a context of culture.² In other words, it concern with the studying of relationship between language and context in which is used. Many people use language to express their thoughts and feeling. Communication exists because of language that is why human can not be far language. By language, people can express their idea, emotion, desire, massage, etc.

Meaning is studied in semantics and pragmatics. Form is studied in morphology or syntax or what is named grammar. Expression is study in phonetic or phonology. The researcher focuses on meaning. Meaning is divided into two: first meaning is related to grammatical unit and meaning in context related to society where language plays.

Text and context are two points of language that cannot be separated one and each other of the system to convey meaning. First, text is based on

Language consist of three levels or strata, namely phonology, lexicogrammatical, and discourse/semantic. In this research, the researcher chooses literary works like songs. The studying was limited on contextual meanings. The researcher things it can explored processes that relate to the transitivity process due to Halliday function system. The

researcher things that transitivity theory is the most theory to analyze the lyrics from the song.

Generally, music consists of two elements, sound as the primary and lyric as the secondary.³ Lyric has significant contribution to the music itself although it contributes as the second element of the music. Lyric gives audience deep understanding about the massage contain in the song. In other word lyric clarify the massage from the song.

A song contains music and lyric. It also one of the form of music, which uses a language. Every song has a special arrangement in music and lyric. It is the way to tell the language. Through the song, the singer wants to tell the listener about the writer's feeling that come from his/her heart .There are song to tell about sadness, happiness, love, social, critique, grateful, etc. The researcher chosen Maher Zain's song because hissong is very interesting to examine and researched in more detail.

CHAPTER II

CONCEPTUAL STUDY

A. Theoretical Description

1. Experiential Function as One of Metafunction

Metafunction of language is a major function of language to give a massage which has good formulation. Metafunction of language consist in three major function they are: the ideational function, the interpersonal function, and the textual function. But, in this research, the researcher focus in experiential function or ideational function on the process.

The ideational function relates to the inner and outer words of reality, it is "language about something". According to halliday said that whenever one reflects on the external world of phenomena or the internal world of one's consciousness, the representation of the reflection would take the form content.¹ This form of content called experiential meaning.

Clauses serve as the unit of experience. Experience is contained in three elements, they are: process, participant, and circumstance. Process is the essence of an experience. The process is determining the participants while circumstance is choice. ² The third aspect of meaning of the clause is meaning as representation. Usually when

Experience is everything happen in our daily activity. Even is good or bad. In experience must be passed by process. The experience can be said good or bad. The human o thing that do or received the process can be said as participant. The participant is determined by the process and the choice can be said circumstance.

Now, we focus of clause in the experiential function. The clause is the way to representing pattern of experience. Language enables human being to build a mental picture of reality, to make sense of what goes on around them and inside them. The clause plays a control role, because it embodies a general principle for modeling experience-namely, the principle that reality is made up of processes.³ The process is the important part of an experience

Our most powerful impression of experience is that consist of going on happening, doing, sensing, being and becoming. All these going on are sorted out in the grammar of the clause. Thus as well as being mode of action, or giving and demanding goods service and information, the clause is also a mode of reflection of imposing order on the endless variation and flow of events.

Experiential Function have a constituent structure that can be described functionally in term of process, participants and

circumstance, with process being the essential ingredient. Bell states experiential function expresses cognitive meaning: the fundamental idea conveying function of language. This draws on the system and networks of transitivity to create proportions which convey the user experience of the external world of the sense and inner world of mind.⁴ With the transitivity system of experiential function become one ways to make our speech completely good. Experiential function concern with the clause that have guises.

So, experiential function relates to what has happened between oneself to external world. The clause represents both action relating to inside of oneself to experience and outside world of some one. According to Halliday and Matthiessen said that we use language to make sense of experience, and carry out our interactions with other people. In this function they have some point to express their experience, they are: participant, process, and circumstance. ⁵ Participants are the entities involve in the process. The circumstance is specifying when, where, how, of the process and processes is what kind/state is being described.

There are types of process and there is basic difference. They are inner and outer experience. The different between inner and outer experience are, the outer is what we experience as going on "out there"

So the process has a types and different.

The grammar sets up a discontinuity between them: it distinguishes rather clearly between outer experience (the process of external world) and inner experience (the process of consciousness). In grammatical categories they are called Material process and Mental process.⁷

So, the different of material process and mental process is, the material process is the prototypical from of the "outer" experience is that of action and events: things happen, and people, or the actors, do things, or make them happen and mental process is the "inner" experience is harder to sour out; but it is partly a kind of replay of the outer, recording it, reacting to it, and partly a separate awareness of the states of being.

The third is relational process. Here, the grammar recognizes the processes of a third type, those of classifying and identifying. It can become a coherent theory of experience. It is learned to generalize: to relate one fragment of experience to another: this is the same as that,

According to Hornby said that process is connected series of action, changes, etc. 9 process are central to transitivity. It centers on that part of the clause that realized by the verbal group, but it can be else regard as 'going-on' are represent in the whole clause.

A process consists in principle of three components:

- 2. Participants in the process
- 3. Circumstances associated with the process

The concepts of process, participant, and circumstances are semantic categories which explain in the most general way how phenomenon of the real world are represent as linguistics structure. These provide the frame of reference interpreting our experience what goes on.

When we come to interpret the grammar of the clause, however, we do not use these concepts as they stand because they are too general to explain very much. We shall need to recognize functions which are more specific than these and which may differ according to the type of process being represented. Nevertheless they all derive from and can be related to these three general categories. So, some experience can be seen from the process, participant in the process and the circumstance that is associate with the process, but it shall need to recognize functions which are more specific than these and which may differ accord to the type of process being represent.

There 6 types of labeling processes they are; material, mental, relational, verbal, behavioral and existential process.

1. Material Process

Material process is process of doing. They express the notion that some entity does something which may be done to some other entity. ¹¹ Material is doing happening. Material process are process in activity that concerning physical activity and is done as real by the actor from the case, the material process can be

observed by sense.¹² It means material process always related something of doing and happening.

Material process expresses an action or an activity which is typically carried out by an Agent. By Agent we mean any entity that is capable of operating on itself or others, usually to bring about some change in the location of properties of itself or others. ¹³ In the simple words, material process is the process of doing. The process is done by the Agent. The process does it to some other entity.

Material process has characteristic is doing a real action or movement and this type relates to physical action, and in this process can see real action of doing this process, for instance walking, bringing, kicking, etc. in this material process the first participants will be called by the actor and second or more participant will be named by the goal. In the inaugural speech. Actor is a person who is the actor or subject of any action or event while goal is that entity who receives the action. ¹⁴ Material process expresses an action or an activity which is

A logical elements (in this sense) a function in transitivity structure. The traditional view of transitivity in western linguistic is as follow: every process has an actor, some process but not all also have a second participant, which may be done to be the goal. For example:

implication is that both cases the Dora do something; but in (A) the do is confine to the Nazmi, whereas in (B) it is direct at, or extend to, the rice. The term goal implies 'direct at'; another tern that has been use for this function is patient, meaning on that 'sufers' or 'undergoes' the process. The familiar term goal in the present analysis, although neither or the two really hits the mark; the relevant concept is more like that of 'one' to which the process is extend.

The concept of extension is in fact the one that is embodied in the classical terminology of 'transitive' from which the 'transitivity' is derived. According to this theory verb read said to be intransitive ('not going through') and verb cooked said to be transitive ('going through', that is extending to some other entity). This is accurate interpretation of difference between them; with the proviso that, in English at least, this concept relate more appropriately to the clause than to the verb. ¹⁵

Material process is process of doing. They express what the participant does or may be done to other participant. We can ask about such processes, or problem them in this way: what the Nazmi do? What Dora do to the rice? Look at the rice point, of view on the other hand, the process is not what doing but what 'happen' so we can said that what happen to the rice? Consequently if there is a goal of the process is well as an actor, the representation may be come in either of two forms: either active, Dora cooks rice, or passive, the rice was cooked by Dora. Like the example bellow:

2. Mental Process

Process is realized by verbs in linguistics side. Mental process is the process on sensing. They are three types process on sensing, they are affective or reactive (feeling), cognitive (thinking), and perceptive (perceiving through the five sense). The senser is a consicious being who can feel, think, or see. The phenomenon is that which is sensed. The participants in this process are called the senser and the phenomenon.

In linguistic side, mental process are one of the six processes proposed. Mental process is the process on sensing. Mental process refresh to verbs indicating perception, cognition, and affection. ¹⁷ It is known as a type of process that relates to sense, feelings, thought, or perception. In this case, the first participant related to sense must be conscious or human being is called by senser, and second participant or the purpose will be named by phenomenon. They are many verbs which

refer to this mental process, such as, think, imagine, like, want, see, know and heard.

This process differs from material because material is process physical, moving and over doing. Mental processes are mental, covert kinds of goings-on and the participant involved in mental processes is not so much acting or acting upon in a doing sense, as sensing-having feelings, perceiving, or thinking. ¹⁸ Mental process is the process of sensing.

So, mental process refer to verb indicting perception, cognition, affection. Mental process is related to psychological matter. The person in whose mind the mental process occur is not really' 'acting'. In the mental process they are two participants, namely; senser (the conscious being that is feeling, thinking or seeing) and phenomenon (which is 'sensed'-felt-thought or seen).

The process mental perception (see, hear, feel, and so on), of cognitive (know, think, believe, recognize, and so on) and affection (like, dislike, love, hate, please and so on) are semantically different from material process of 'doing' and this differences are reflect in grammar in several ways.¹⁹

- a) There is typically one participant who is conscious, and can be called the Experiencer; this is the one who sees, feels, thinks, likes, and so on, and is typically human, but may also be an animal. (The reader heard a noise. The horse sensed danger). The use of the noon conscious entity as Experiencer in a mental process is often exploited for commercial ends.
 - Your car knows what it needs.
 - This airline cares for you.
- b) There is usually a second participant in a mental process, that which is perceive, known, like and so on, and which may be a 'thing' realized by a NG, but can also be a fact, a process or an entire situation, realized by a clause. This participant can be called the phenomenon.
- c) Verbs of mental processes are typically sativa verbs and consequently the unmarked tenseaspect form is the non-progressive (I know the answer, not I am knowing the answer). Material

processes, on the other hand, are typically dynamic and take the progressive as their unmarked tense-aspect (what are you doing? I am reading this script, not what do you read? I read this script). A mental process cannot be questioned by 'what did X do?' as can a material process. Compare: what did Mary do with the gift? She gave it away. She liked it.²⁰.

3. Relational Process

Relational process is the process of being (including having). It involves with the statement of identifying something. It also involves with the quality identification of something. In addition to that, it also involves and with the identity identification. ²¹ Relational process can be classified according to whether they are being used to identify something or to assign a quality to something.

Relational process involves state of being ²². Relational process is typical realized by the verb be (an, is, are, was, were, been) became, seem, and appear or some verb of the same class (known as copular verb). They are two classification in relational process, they are; relational attribute and relational identifying process. In the relational attribute, the first participant will be named by carrier while the second participant

Relational process plays a key role in education in subject such as science, geography, mathematics, and economics. It is through these processes that these subject create an ordered technical vocabulary, and a way of classifying the world. They are fundamental in how the above mention subject construct the world.

4. Verbal process

activities related Verbal process show to information. Especially the process include that of saying, commanding, asking, and offering.²³ It means that verbal process is process of saying symbolically signaling.

Verbal process of saying, as in what did you say?. This process is tended to verbal communication.

The potential participant roles, they are:

- a. A receiver as the one whom the saying, it may be the subject a passive clause.
- b. A verbiage as the function that corresponds to hat is said
- c. A target as entity that is targeted by the process of saying.²⁴

5. Existential process

Existential process show that something exists or happens. The word there is frequently use in such clauses, but it has no identified function or meaning, and is merely a subject filler. The typical verbs use in these clauses are be, exist, arise, and other verbs expressing existence. The nominal group follow this verb is called existent. ²⁵ It represent that something exist or happen. It also represents experience by positing "there was/is something.

6. Behavioral Process

Behavioral process is process of psychological or psychological behavior. ²⁶ Here

Sometimes it is difficult to distinguish Behavioral processes and Range from Material processes with Goal and Range. But, if look more attention both of them we can find that behavioral displays many features of process, the process of like one "do" than one of "think or feel". The evidence for this un mark present tense for behavioral and material is present continuous tense

So, the behavioral process what is usually done in every day. They are partly like the material and partly like the mental process. But, in the behavioral process, range names the behavioral enacted. Range specifies the range or scope of the process. Defining its coordinates or domain. Sometimes it is difficult to distinguish behavioral processes and range from material process with goal and range.

b. Participant

Participant is the person, creature, object, intuition, or abstraction than involves in process. In experiential function, participant accompanies the six process. The participant may take ways in part of process, they are; it may act out the process, it mat sense through it, it may receive of it, it may be affected by it, it may say it.²⁷ Participant provides the answer to such question as who or what, filling in detail of the immediate situation of utterance in which the process occurs and of which the text is a representation.

Process is nucleus that binds all other elements, especially participant. As a core that has an appeal or a tie, the process potential determines the number of participant that can be

c. Circumstance

Circumstance is environment nature, location, of the beyond Circumstance is the reach process. Circumstance consists of extents that can be distance or time, manner, cause, contingency, accompaniment, and matter. ²⁹ Circumstance is same with adverb. But in linguistics side is call by circumstance.

Circustance divided into "simple" and "macro". Simple circumstances, the most usual are those of time, place, and manner-quality and intercity, all of which are circumstances of enhancement. Examples: (she does the work hardly) today (locative: time), increasingly (manner: intensity), widespread (locative: place), easily, carefully, (manner: quality).

Macro circumstance are those which are made up of a special type of figure having another participant inside it, for example (circumstance of enhancement): (locative: place /abstract/) in the low to mid 60s. (Locative: place) in the house, (manner: quality) at 15 to 25 mph, (extent: duration) for 10-15 minutes, (manner: means) with clean absorbent cloth. 30

CHAPTER III

The source of the data used in this research is Maher Zain song lyrics "Guide e All The Way". The data are in the form of clauses in the lyrics.

The research would involve lyrics of "Guide Me All The Way" that taken from internet by researcher. The song lyric as a document to analysis.

D. Technique of Data Collection

Data collection method are ways that can be used by researcher to collect data. ⁹ Documentary study is a technique of data collection by mastering and analyzing the documents, even written document, picture and electronic. ¹⁰ This research is written document. So the documentary study can be used for this research. The steps for documentary study are:

- 1. Analysis is to describe Process after making the lyrics in clauses.
- 2. Calculation is to decide description of Process used and percentages.
- Perception is to perceive and explain the point of view on the result of the research.

E. Technique of Data Analysis

In this research, the researcher employed the content analysis in written words of Maher Zain song lyrics "Guide Me All The Way" to find the analysis of the interpersonal function. The followings were the steps of the data analysis of this study:

Experiential function realizes in lyrics. The analysis data will be administering in the following steps. They are:

1. Identifying process in song "Guide Me All The Way".

After the clause is analyzed, the researcher finds the dominant process in song guide me all the way.

3. Explaining the dominant process in song "Guide Me All The Way". This examines the description of data, the reason based some sources of song to be as discussion.

F. The Location and Time of The Research

This research would done through watching the video of Maher Zain.

The location of research at the house Padangsidimpuan. The time of the research at 20 September 2016 until 13 October 2017.

CHAPTER IV

RESEARCH RESULT

A. Data Analysis

The data found in Maher Zain song and specified based on aim at describing the process of "Guide Me All The Way". The lyrics was found in internet (see Appendix A). Next, the sentence was made in the division of clause (see Appendix C).

The paragraph of the song are eight paragraphs. A paragraphs can be two or more clauses. Like in the table above, the first paragraph was divided in to twelve clauses. The second paragraph was divided in to seven clauses. The third paragraph was divided in to thirteen clauses. The fourth paragraph was divided in to seven clauses. The fifth paragraph was divided in to eight clauses. The sixth paragraph was divided in to four clauses. The seventh paragraph was

divided in to seven clauses. And the last paragraph or the eighth paragraph was divided in to three clauses. The total number of the clauses were sixty one clauses.

The clauses were analyzed by using experiential function. Processes, participant and circumstance were analyzed in every clauses. The clause of division were made based on principle that every clause contained only one process in all clause. Based on table, the processes that were used in the clauses are, material process, mental process, relational process and behavioral process, but the verbal process, existential process were not used in this song.

The process determined the participants in the clause. Every clause must have participant because the participant is the agent of the process. Every process had different participant. The participant in song were 95 participants. The kinds of participant were actor, goal, senser, phenomenon, token, value, prosseser, possessed and behaver. Circumstance is environment nature, and location of the process. Circumstance is beyond the reach of process. Therefore, circumstance label applies to all types of process. The circumstances were used in the clauses are Location, Contingency, manner, matter, accompaniment.

B. Process in Maher Zain's Song "Guide Me All The Way"

Process is connected series of action, changes, etc. After analyzing the song in Maher Zain's Song "Guide Me All The Way", the researcher identified the process found in Maher Zain's song "Guide Me All The Way". Process that used in the song are: material process, mental process, relational process and behavioral process, but the verbal process and existential process were not used in this song.

1. Material process

Material process is process of doing. Material process express an action or an activity which is typically carried out by an agent. The process does it to some other entity. In this song were found the material process on the clauses. The clauses that used the material process in Maher Zain's Song "Guide Me All The Way" are as follow: the process in the clause number two was **take away**, the process of clause number three was **given**, the process of clause number six was **do not**, the process of clause number seven was **to take**, the process of clause number ten **come**, the process of clause number fourteen was **do not late**, the process of clause number fifteen was **go**, the process of clause number twenty one was **do**, the process

of clause number twenty two was **do**, The process of clause number twenty eight was **pray**.

The process of clause number twenty nine was **stops**, the process of clause number thirty was **comes**, the process of clause number thirty four was **don't late**, the process of clause number thirty five was **go**, the process of clause number forty four was **let**, the process of clause number forty nine was **don't late**, the process of clause number fifty was **go**, the process of clause number fifty three was **don't late**, the process of clause number fifty four was **go**, the process of clause number sixty was **don't late**, and the last, clause number sixty one was **go**. All this process were material process because all this done by doing.

2. Mental Process

Mental process is process of sensing. They are three types of process on sensing, namely affective or reactive (feeling), cognitive (thinking), and perceptive (perceptive through the five sense). The participant in this process are senser and phenomenon. The clauses used mental process are, the process in the clauses of number one was **know**, The process of clause number four was **try**, the process of clause number eight was **know**, the process of clause number twelve was **to be pleased**, the process of clause number thirteen was **guide**, the process

of clause number sixteen was **need**, the process of clause number seventeen was **wish**, the process of clause number twenty was **know**, the process of clause number twenty three was **could be**.

The process of clause number twenty four was forgive, the process of clause number twenty six was forgive, the process of clause number twenty seven was doubt, the process of clause number thirty two was pleased, the process of clause number thirty three was guide, the process of clause number thirty six was need, the process of clause number thirty seven was wish, the process of clause number thirty eight was close, the process of clause number forty one was think, the process of clause number forty two was could be, the process of clause number forty three was pray.

The process of clause number forty eight was **guide**, The process of clause number fifty one was **need**, the process of clause number fifty two was **guide**, the process of clause number fifty five was **need**, the process of clause fifty six was **wish**, the process of clause number fifty seven was **close** and the last, the process of clause number fifty nine was **guide**.

3. Relational process

Relational process is process of being (including having).

Relational process involve states being and including having.

Relational process has three classification, they are, relational of

identification, relational of attribution and relational of possession. Many clauses found in song Maher Zain's "Guide Me All The Way" about relational process, they are, the process of clause number nine was **will**, and it used relational identification process, the process of clause number eleven was **is**, and it used relational identification process, the process of clause number nineteen was **be**, and it used relational possession process, the process of clause number thirty one was **is**, and it used relational identification.

The process of clause number thirty nine was **be**, and it used relational possession, The process of clause number forty five was **be**, and it used relational possession, the process of clause number forty six was **not**, and it used relational possession, the process of clause number forty seven **will have to leave**, and it used relational possession, the process of clause fifty nine was **be**, and it used relational possession.

4. Behavioral Process

Behavioral process is process of psychological behavior. The behavioral process that found in this song is the process of clause number forty was **passes**.

The verbal clause and the existential clause was not found in this song. Verbal process is process of saying or signaling, so it was not used in this song and also existential process was not used in this song

because existential process is process of existence. The analysis was done in table form (see Appendix C).

C. The Dominant Process in Maher Zain's Song "Guide Me All The Way"

After all of clause analyzed, the processes were accounted and make the percentages every clause. The percentages were described in the following table

Based on table above, the verbal process and existential process was not used in the song. There were 20 material process (33%), there were 28 mental process (46%), there were 12 relational process (20%), and there were 1 behavioral process (2%). From the percentages and the total of clause could be found that the dominant process were mental process and material process.

D. The Explanation of the Dominant Process in Maher Zain's Song "Guide Me All The Way"

The dominant process in Maher Zain's song "Guide Me All The way" is mental process. It is supported because there are many clauses

containing about the feeling, thinking, and perceiving. From the mental process could be identified how to thank you to Allah. If I see from Maher Zain's lyric "Guide Me All The Way" talked about the singer wants to be guide to right way and to the Allah's paradise. Then, the singer fells regret that Allah love his servant so deep and he thanked to Allah for what Allah has given. So we should always to be grateful to Allah for anything that Allah given to human life.

When a Muslim believes in Allah as the God of mercy, he realizes that he should thankfully worship Him. Most of those all was done by mental sense. We must be patient and effort to look for that. And if it later, we broken heart and disappointed because someone we can not to stay in this situation and may be for closing our heart to other love. But look in the future and say to your heart to go from the sadness come to new situation, and always to look for and open our heart to someone who special again. And do not forget to pray to Allah certainly in order that we near.

A confession of the singer that god will hears people pray. God is standalone never need everyone and has everything given to his believer. And also give contribution the moral values of religiosity the singer always calls Allah in his heart. He wants to remember Allah long time and every close to Allah an hope it for His mercy.

Now we see back to the meaning of mental process. The process of mental is the process on sensing. They can be classified into three types, they are affective or reactive (feeling), cognitive (thinking), and perceptive (perceiving through the five sense). In process of mental there is no movement.

In the song lyrics are many mental process for example in first clause (I know), in fifteenth clause (so my last wish for you to be pleased me and other. It is show that Allah will hear and answer every wishes of the people that pray to Him.

So, mental process is the process is done from inner or our mental. There is no much acting in mental process and there is no moving here. Everything is done with mind is constituted the process of mental process. This process is semantically different from material process of doing, these differences are reflected of the grammar in several ways. From this song mental process because this song tell us that Allah is the most forgiving to the person that wants return to right ways. He is always for the person who need him.

From the meaning of mental process and contain of the song, the experience in the song was about sensing. It is supported by the song was containing about the basics of 'belief,' 'worship' and 'conduct'. So, it can be concluded that mental process was the dominant process in the song.

E. Discussion

By seeing the finding above, the Experiential Function structures gave contribution to see what was going on in the text based on the context. This research found the elliptical semantic unit of process and participant by using the Experiential Function structures. The following discussion would elaborate the deviation between theory and finding of Experiential Function in Maher Zain's song "Guide Me All The Way"

From the Experiential Function structures, the researcher knows how the experience in the song is. The clause that is divided from the paragraph of song analyzed because the clause paragraph as the unit of experience. Process is the essence of an experience. The process is determining the participants while circumstance is a choice. Every clause was determined what process was used.

The process were used in Maher Zain's song "Guide Me All The Way" 20 material process (33%), there were 28 mental process are (46%), there were 12 relational process (20%), and there were 1 behavioral process (2%).

The dominant process was mental process. The experience in the song was about sensing. The feeling and the mind of human is boundless with Allah. Because of that if the human knows who is Allah, they will believe, thanks be to Allah and worship Him. He always around for the person who need Him

The researcher had found the difficulties when determined the process. The researcher sometimes was confusing in identifying it was the mental or material process. Mental and material are the two main types of process in the English transitivity system. But the researcher saw back to the meaning of the song from context. In the last the researcher found the mental process was the dominant process. The other dominant was material process.

From the Experiential Function structures, the song was explain that the song was made from the sensing experience. If we did or experienced every things in the song by sensing and not just knowing, we would be boundle with Allah. If the feeling had been felt, we would realize that we should thankfully worship Him. We must always grateful to Allah that always keep us. We always pray that Allah guide us to the right way.

The findings were enrichment to the previous study. Those enrichment with variations of process by using elliptical semantic unit of process and participant. There were the elliptical semantic of participant also. The elliptical semantic unit was found actually after analyzing the data.

Ellipsis was found from the social context of language. That social context was the reconstruction of linguistic element previous and after. This social context determined what the meaning of the elliptical linguistic element was. Normally, ellipsis was very close to the linguistic element previous and

after that tailed to be a meaning, and the meaning was not far away from the constructed linguistic element.

The ellipsis gave help the researcher's difficult thing in the analysis. If the ellipsis was not known, the researcher could not determine the process.

The ellipsis that was found in the clauses were elliptical of word. From the elliptical semantic, the analysis of Experiential Function in the clauses could be finished.

The example from ellipsis that used researcher in the analyze there are from first paragraph one of them is I, the second paragraph one of them is Allah, the third paragraph one of them is it, the fourth paragraph one of them is Allah, the fifth paragraph one of them is this world, the sixth paragraph one of them is I, the seventh paragraph one of them is Allah, and the last in the eight paragraph one of them is I. From the elliptical semantic the analysis of experiential function in clause could be finish.

CHAPTER V

CONCLUSIONS AND SUGGESTIONS

A. The Conclusion

The conclusion of this research is drawn based on the data analysis, findings and discussion as the following.

- The processes those are used in the clauses of Maher Zain's song "Guide Me All
 The Way" are mental process, Material Process, Relational Process and
 behavioral process.
- Mental process is used dominantly in the Maher Zain's song "Guide Me All The
 Way. Material process also dominantly in this song. But, the mental process is
 more dominant it all.
- 3. Mental process is dominantly in this song, because it is known that the experience in the song is about the feeling, cognitive and thinking. From mental process can show one's wishes to always in beside Allah. Human preparing themselves to get Allah's Jannah.so, could be concluded that mental process was dominantly in this song. The material also dominant in this song because, material process is express and action or an activity which is typically carried out by agent.. Human doing the best in this world to get Allah's Jannah for one day. So, can concluded that material process is also dominant in this song.

B. Suggestion

- 1. The researcher feels that describing the process in Maher Zain's Song "Guide Me All The Way" is a challenge in the song "Guide Me All The Way". The analysis gives some good experience. For example to understand it in creating the experience need deepen language ability. For example in string up the clauses because in the clauses are many linguistic element that is hidden or called the elliptical element. The problem is, the researcher just analyze the song and it is not enough. To test my language ability and bring into reality the song certainly it is expected to the next researchers to do the research of the next song in the Maher Zain.
- 2. The process used in the song are: material process, mental process, relational process and behavioral process. The dominant in this song is mental process and material process. Mental process dominantly it is supported because mental process is process of sensing. The clauses in this song many about feeling, thinking and perceiving so can conclude the mental process is dominant in this song. Material process also dominant in this song, because many clauses in this song also contained of doing. So, material process dominant in this song.
- 3. The reason of the dominant process of mental process and material process in the song, it is absolute song connecting between feelings, thinking of human, and human more understand more about meaning in the song. The writes hope

this graduating paper could be a reference for those want to do further research in the others song lyric of moral values and literary.
